

1. FAMILY RESIDENCE PERMIT

1.1. Foreigners married to Turkish citizen

1.1.1. First application

From the person himself/herself;

- Residence Permit Application Form
- Original and photocopy of the passport or travel document
- Four (4) photograph
- Document regarding the marriage

From the sponsor; (Shall be present during the application)

- Original and photocopy of the identity card
- Document regarding sufficient and sustainable resources for the duration of their stay
- Valid health insurance covering all the family members (one of the followings shall be sufficient):
 - Document enabling health services in Turkey within the scope of bilateral social security agreements
 - Provision document issued by Social Security Institution
 - Document regarding the application made to the Social Security Institution to have general health insurance
 - Private health insurance
- Criminal record certificate (Shall be issued by person's own competent authorities or Turkish judicial authorities in case the person stays in Turkey for the last 5 year.)
- Document regarding the registration on the address based registration system

1.2. Foreigners with Permission for One Year Residence Permit in Turkey, with Work Permit, Refugees, Persons' Spouses with Subsidiary Protection

1.2.1. First application

From the person himself/herself;

- Residence Permit Application Form
- Original and photocopy of the passport or travel document
- Four (4) photograph

From the sponsor; (Shall be present during the application)

- Original and photocopy of the passport or travel document (if available passport or travel document for refugees and subsidiary protection beneficiaries)
- Submission of the original residence/work permit document, identity card belonging to the refugee or subsidiary protection beneficiary
- Document regarding the marriage

- Document regarding sufficient and sustainable resources for the duration of their stay
- Valid health insurance covering all the family members (one of the followings shall be sufficient):
 - Document enabling health services in Turkey within the scope of bilateral social security agreements
 - Provision document issued by Social Security Institution
 - Document regarding the application made to the Social Security Institution to have general health insurance
 - Private health insurance
- Criminal record certificate (Shall be issued by person's own competent authorities or Turkish judicial authorities in case the person stays in Turkey for the last 5 year.)
- Document regarding the registration on the address based registration system

1.2.2. Renewal application

From the person himself/herself;

- Residence Permit Application Form
- Original and photocopy of the passport or travel document
- Submission of the previous residence permit
- Two (2) photograph

From the sponsor; (Shall be present during the application)

- Original and photocopy of the passport or travel document (Passport or the travel document for the refugees and subsidiary protection beneficiaries shall be demanded)
- Submission of the original residence/work permit document, identity card belonging to the refugee or subsidiary protection beneficiary
- Document regarding the marriage
- Document regarding sufficient and sustainable resources for the duration of their stay
- Valid health insurance covering all the family members (one of the followings shall be sufficient):
 - Document enabling health services in Turkey within the scope of bilateral social security agreements
 - Provision document issued by Social Security Institution
 - Document regarding the application made to the Social Security Institution to have general health insurance
 - Private health insurance
- Criminal record certificate (Shall be issued by person's own competent authorities or Turkish judicial authorities in case the person stays in Turkey for the last 5 year.)
- Document regarding the registration on the address based registration system

1.3. Foreign Minor Children – Dependent Foreign Children

1.3.1. First application

From the person himself/herself;

- Original and photocopy of the passport or travel document
- Four (4) photograph

From the sponsor; (Shall be present during the application)

- Residence Permit Application Form
- Identity card (for the sponsor being Republic of Turkey citizen), original and photocopy of the passport or travel document (if available passport or travel document for refugees and subsidiary protection beneficiaries)
- Submission of the original residence/work permit document, identity card belonging to the refugee or subsidiary protection beneficiary
- Other spouse's letter of consent in case both shares custody
- Document regarding sufficient and sustainable resources for the duration of their stay
- Valid health insurance covering all the family members (one of the followings shall be sufficient):
 - Document enabling health services in Turkey within the scope of bilateral social security agreements
 - Provision document issued by Social Security Institution
 - Document regarding the application made to the Social Security Institution to have general health insurance
 - Private health insurance
- Criminal record certificate (Shall be issued by person's own competent authorities or Turkish judicial authorities in case the person stays in Turkey for the last 5 year.)
- Document regarding the registration on the address based registration system

1.3.2. Renewal application

From the person himself/herself;

- Original and photocopy of the passport or travel document
- Submission of the previous residence permit
- Two (2) photograph

From the sponsor; (Shall be present during the application)

- Residence Permit Application Form
- Identity card (for the sponsor being Republic of Turkey citizen), original and photocopy of the passport or travel document (if available passport or travel document for refugees and subsidiary protection beneficiaries)
- Original and photocopy of the residence/work permit document, identity card belonging to the refugee or subsidiary protection beneficiary
- Letter of consent in case the duration is not sufficient (of mother or father)

- Document regarding sufficient and sustainable resources for the duration of their stay
- Valid health insurance covering all the family members (one of the followings shall be sufficient):
 - Document enabling health services in Turkey within the scope of bilateral social security agreements
 - Provision document issued by Social Security Institution
 - Private health insurance including the duration of renewal
- Criminal record certificate (Shall be issued by person's own competent authorities or Turkish judicial authorities in case the person stays in Turkey for the last 5 year.)
- Document regarding the registration on the address based registration system
